Jamboree Basics -

Group Play: 3 points for a win, 1 point for a tie, 1 bonus point for a clean sheet (no goals against), and 1 bonus point for multiple goals (2 or more). (Tie-breaks decided by 1. Head to Head Result 2. Goals For Advantage 3. Goals Against Advantage).

Semifinal, Consolation and Championship matches - If tied at the end of regulation time, two overtime periods played (no sudden death or "golden-goal"), if still tied, 5 players per team attempt alternating penalty kicks, if still tied . . . it's a tie!
